- System of play: The Tournament will be governed as per the latest FIDE laws of Chess & the Swiss System.
- Arbiter decision will be final.
- If any player is absent from any round without intimation to the Chief Arbiter. He/ She will not pair in all next round.
- PROTEST:-Protest if any against the decision of the chief arbiter shall be made in writing with a protest fee Rs 1000 with in 15 minutes of the occurrence of the incident. Protest Fee will be refund if the appeal is up held.
