

# Tournament regulations

## Article 1.

The Petrović family in cooperation with the Braničevo District Chess Federation is organizing a memorial tournament „Vojkan Petrović“ from 12-14. december.

## Article 2.

The tournament will be played in Banja Ždrelo in hotel „Mlavske Terme“. There will be 6 rounds, here is the schedule of rounds:

1 round: 12.12.2025. in 15:00h

2 round: 12.12.2025. in 19:00h

3 round: 13.12.2025. in 13:30h

4 round: 13.12.2025. in 17:30h

5 round: 14.12.2025. in 10:00h

6 round: 14.12.2025. in 14:00h

## Article 3.

The tempo of the game is 60 minutes plus 30 seconds, computer matching - Dutch variant FIDE rules for standard chess apply. The organizer provides the necessary inventory.

## Article 4.

The registration fee for participation in the tournament is 3000 dinars. Grandmasters are exempt from the entry fee.

## Article 5.

In case of a tie, the additional criteria are as follows:

1. Buchholz -1 (without the lowest-ranked opponent)
2. Results of players within the same point group (head-to-head results)
3. Sonneborn–Berger
4. Full Buchholz
5. Ahrens system
6. Drawing of lots

## Article 6.

Prize fund: For the expected 70 registered players:

1st prize 40,000 RSD

2nd prize 32,000 RSD

3rd prize 25,000 RSD

4th prize 20,000 RSD

5th prize 17,000 RSD

6th prize 14,000 RSD

The condition for regular prizes is the participation of 70 players in the tournament. In other cases, there will be a correction .

Special prizes:

Best senior S60 born in 1965 and earlier 6,000 RSD

Best youth U18 born in 2007 and later: 6,000 RSD

Best female chess player: 6,000 RSD

Best player in the Braničevo district: 6,000 RSD

### **Article 7.**

Prizes are indivisible and determined based on placement. In case the player achieves two prizes, the player will receive a higher monetary reward.

### **Article 8.**

Electronics like phones and smart watches are not allowed in the playing hall. Analyzing games in the playing hall is strictly prohibited. Players are allowed to be late for a game 30 minutes. Except in exceptional cases, when the chief arbiter may permit a longer waiting time for the game.

### **Article 9.**

Chief arbiter for the tournament is FA Marija V Petrović, deputy chief arbiter is NA Tamara Petrović. The decisions of the chief arbiter of the tournament are final and binding. The director of the tournament is IA Tijana Petrović.

### **Article 10.**

This regulation has been issued by the organizer, and all participants confirm their agreement with it by making their first move in the tournament.
