## **Rules:**

**Eligibility:** Only Tripura state players are eligible to participate in the Championship.

**Age Limit:** Players should be born on or after 01. 01.2017

**Selection:** Top 2 Boys and Girls Players will be selected for both Open and Girls National Championship from a common event.

**Prizes:** Trophies will be given to top four Boys and Girls during Annual Prize Giving Ceremony.

**Financial Assistance:** Two selected players each from both categories will get Rs 3000/- (Three Thousand only) each as travelling allowance after national participation.

**Schedule :** 18<sup>th</sup> April 2026 : 09:30 Hrs / 13:00 Hrs / 17:00 Hrs  
19<sup>th</sup> April 2026: 09:30 Hrs / 13:00 Hrs / 17:00 Hrs

**System of Play :** The championship will be played under FIDE Laws of chess & Swiss System. Total six rounds will be played

**Default Time:** Default timing for arriving to the chess board is 15 minutes.

**Time Control:** The rate of play shall be 60 minutes with an increment of 30 seconds from move number one.

**In case of tie,** the latest FIDE approved tie breaks will be followed.

**Draw Agreement:** Players shall not agree for a draw without consent of the Arbiter, before each player makes 30 moves.

**Protests,** if any, against the decision of the Chief Arbiter, shall be made in writing with a protest fee of Rs.1,000/- (Rupees one thousand only) within 30 minutes of the occurrence of the incident. The amount shall be refunded if the appeal is upheld.

**Electronic Devices:** All electronic items including wrist watches (All types of watches) are not allowed in the hall
