







## MTB International Masters Chess Tournament, 2025

14 to 24<sup>th</sup> December, 2025 Dhaka, Bangladesh

The MTB International Masters Chess Tournament, 2025, sponsored by Mutual Trust Bank PLC, organised by the Independent University and associated by Bangladesh Chess Federation which will be held in Dhaka, Bangladesh from 14<sup>th</sup> to 23<sup>rd</sup> December, 2025.

### **Participants**

Total 10 invited IM's, FM's, CM and FIDE Rated plyers will participate in the event.

#### **Tournament System and Time Control**

The tournament will be held in all play all (Single Round-Robin League) system and will be governed by FIDE - the official laws of chess (which were adopted at the 88<sup>th</sup> FIDE Congress at Goynuk, Antalya, Turkey) coming into force on 1 January 2018.

**Time Control:** The Session will start from 2:00 PM at Multi-Purpose Hall in Independent University, Bangladesh (IUB).

The time control for each game is: 90 minutes for whole game with an increment of 30 seconds per move starting from move 1. Last round will start on 23<sup>rd</sup> December, 2025 from 10:00 AM

Default Time: 30 minutes from round starting time.

- 1. The 'playing venue' is defined as the 'playing area', rest rooms, toilets, refreshment area, area set aside for smoking and other places as designated by the arbiter. The playing area is defined as the place where the games of a competition are played. Only with the permission of the arbiter can: a player leave the playing venue. The player having the move be allowed to leave the playing area. A person who is neither a player nor arbiter be allowed access to the playing area.
- 2. (a) During play the players are forbidden to use any notes, sources of information or advice, or analyse any game on another chessboard.
- (b) During play, a player is forbidden to have a mobile phone and/or other electronic means of communication in the playing venue. If it is evident that a player brought such a device into the playing venue, she shall lose the game. The opponent shall win. The rules of a competition may specify a different, less severe, penalty. The arbiter may require the player to allow her clothes, bags or other items to be inspected, in private. The arbiter or a person authorised by the arbiter shall inspect the player and shall be of the same gender as the player. If a player refuses to cooperate with these obligations, the arbiter shall take measures in accordance with Article 12.9.
- (c) Players who have finished their games shall be considered to be spectators.
- (d) It is forbidden to distract or annoy the opponent in any manner whatsoever. This includes unreasonable claims, unreasonable offers of a draw or the introduction of a source of noise into the playing area.
- (e) Smoking is permitted only in the section of the venue designated by the Arbiter.
