1. THE TOURNAMENT SHALL BE CONDUCTED ON A 9 ROUNDS SWISS SYSTEM WITH TIME 15 MIN+5 SEC INCREMENT PER MOVE FROM MOVE NO 1 IN RAPID AND 8 ROUNDS SWISS SYSTEM WITH TIME 3 MIN + 2 SEC INCREMENT PER MOVE FROM MOVE NO 1 IN BLITZ.
2. WRIST WATCHES & MOBILE PHONES ARE STRICTLY NOT ALLOWED INSIDE THE PLAYING HALL.
3. PROTEST IF ANY, AGAINST THE DECISION OF CHIEF ARBITER SHALL BE MADE IN WRITING WITH PROTEST FEE OF RS.1000/- WITHIN 15 MINUTES OF THE OCCURRENCE OF THE INCIDENT TO THE APPEALS COMMITTEE. THE PROTEST FEE WILL BE REFUNDED IF THE APPEAL IS UPHELD.
4. NO SPOT ENTRIES WILL BE ENTERTAINED
5. REPORTING TIME FOR RAPID IS 1:45 PM FOLLOWED BY INAUGURATION AT 1:55 PM ON 11TH APRIL. ROUND 1 WILL START AT 2:15 PM SHARP. PD FUNCTION WILL BE AT 5:30 PM ON 12TH APRIL.
6. REPORTING TIME FOR BLITZ IS 1:15 PM AND ROUND 1 WILL START AT 1:40 PM SHARP ON 12TH APRIL. PD FUNCTION WILL BE AT 5:30 PM ON 12TH APRIL.
