Official Tournament Regulations

Organized by the Dauin Sports Association (DASASS)

I. General Guidelines

The tournament shall be governed by the latest FIDE Laws of Chess and the following ground rules adapted from rapid chess regulation formats

A. Event Details

Event: 7-Round Swiss System Tournament

Format: Rapid Chess

Time Control: 15 minutes + 5 second's increment

Date & Time: December 6, 2025 (Saturday), starts at 10:00 AM

Venue: Lamiah Kitchenette, Dauin

Organizer: Dauin Sports Association (DASASS)

Technical Director & Chief Arbiter: Engr. Alvin Alcala

B. Participation Eligibility

Exclusively for bona fide residents, students, and workers of the Municipality of Dauin.

Participants may undergo eligibility verification if required.

C. Tournament System

Swiss System, 7 rounds.

Swiss Manager pairing software will be used.

Pairings are computer-generated; no pairing protests allowed.

Late arrivals may be given a bye for Round 1 upon discretion from the organizers.

A player absent without notifying the arbiter is considered withdrawn.

Players who failed to play against each other in previous rounds may be paired again in later rounds.

Initial ranking will follow:

D. Equipment
Chess clocks, mats, and pieces will be provided by the organizer.
E. Playing Area Rules
No eating inside the playing area while games are in progress.
Players must report (check-in) to the Pairing Manager from 9:00–9:45 AM for confirmation.
Pre-registered players who fail to check-in may be paired only starting Round 2.
II. Rules and Regulations
1. Time Control
15 minutes + 5 seconds increment for the entire game.
2. Notation
Recording of moves is not required.
3. Result Submission
Players who won or both players in case of a draw must report the results at the arbiter's table.
4. Touch-Move Rule
Touch-move and touch-take rules are fully enforced.
5. Flag Fall
Arbiters may intervene in clear cases of flag fall.
6. Draw Rules
No quick draws (Grandmaster draw) allowed.
Draw offers allowed only after Black's 30th move.
Draw claims allowed by the players under:
Threefold repetition
50-move rule
7. Illegal Moves & Infringements

Illegal Moves:

Using two hands Pressing the clock without moving Leaving the king in check Capturing an illegal king Illegal promotion Wrong movement of pieces Penalties: 1st offense: +1 minute to opponent 2nd offense: loss of game Infringements: Disturbance Misplacing pieces Using a piece to press the clock Penalties: 1st offense: warning 2nd offense: +1 minute to opponent 3rd offense: loss of game 8. Zero Default Time No default time. The clock will run until it expires. 9. Scoring Win = 1 point

V. Appeals and Protest Committee

The decision of the Chief Arbiter on a point of law is final.

Protests on factual matters must be:

Filed within 10 minutes after the game submitted in writing and signed with a ₱300 protest fee (refundable if upheld)

Appeals Committee shall be composed of DASASS Tournament Officials.

VI. Conduct and Anti-Cheating Measures

Mobile phones must be switched off.

A player whose phone makes a sound loses the game.

No analysis or discussions allowed inside the playing area.

Players who finish their games are considered spectators and must leave the area.

Arbiters will enforce FIDE Anti-Cheating measures.

VII. Miscellaneous Provisions

Matters not covered in this document shall be decided by the Organizing Committee.

Organizers reserve the right to refuse entries that may disrupt the tournament.

Updates may be issued if necessary.
