RULES AND REGULATIONS

• System Of Play: The tournament will be conducted as per latest FIDE Laws of Chess and FIDE Swiss System

No. of Rounds: 9 Rounds

Time Control: 3 min for game with 2 sec inc from move 1 Default Time: (walk over time) 3 Minutes

Electronic Devices: All Electronic items including wrist watches (all type of watches) & cell phones will not be allowed in tournament.

Tie Break: In case of tie, following criteria will be used in descending order

- (a) Buchholz cut one (b) Buchholz (c) Sonneborn Berger (d) Direct Encounter (e) Greater no. of victories
- (f) Greater no. of wins by black

Eligibility: Open for all players

Prize: Player qualified for more than one prizes will be considered only for higher prize in the respective cate gory.

Discipline: Maintaining tournament decorum is essential; Any player or parent causing disturbances may be removed from the event

Appeals Committee: An appeals committee will be formed during the technical meeting.

Protest: Protest if any against the decision of the arbiter shall be made in writing with protest fee of Rs. 1000 (rupees one thousand only) within 15 mins of incident. The protest fee is refundable only if the protest is upheld. The decision of appeals committee on all protest shall be final and binding.

Interpretation: For interpretation of the rules and deciding any point not covered by the rules, the decision of tournament committee shall be final and binding.

Withdrawals: Player may withdraw at any stage of the event after informing the chief arbiter in writing.

Refund: Refund of entry fees will be given only if entry is cancelled before the pairing of round one.
