Minutes of Technical Meetings

- 📄 **Pairing Software:** Swiss-manager & Tournament upload on www.chess-results.com
- 📄 **System of Play:** 9 Rounds (Swiss system under FIDE Laws of Chess)
- 📄 **Time Control:** 90 Minutes with 30 Seconds increment from move No. 1
- 📄 **Tie Breaks:** **1)** Buchholz Cut 1, **2)** Buchholz, **3)** Sonneborn-Berger, **4)** Direct Encounter, **5)** Number of victories, **6)** Number of wins with Black.

- 📄 **Default Time:** **30 Minutes walkover time.** If a player absents for a round, he/she should inform the Chief Arbiter before the next round pairing to retain their name in the Pairing list. Otherwise, they will not be paired for the next round.

- 📄 **Fair Play Procedure (FPP):** FIDE Fair Play Regulations will be enforced including private checking during the event and all players are to respect the regulations and cooperate with officials. Players are strictly forbidden to bring mobiles, any source of chess information material or any electronic devices to the tournament hall which includes all types of wrist watches. If the same found during the game, players are liable to lose the game and further participation in the tournament will be decided by Chief Arbiter on Merit of the case.

- 📄 **Disqualification:**
 - 1.** If any player found conceals his identity (concealing rating / playing with different identity), the player concerned will be expelled from the event without any prior notice. If found after completing event then we will remove the player from Final Rank & also revoke his / her prize and taking necessary action under AICF & FIDE Fair Play Procedure.
 - 2.** Any Player / Parent / Manager / Coach / Guardians threatening to any player / organizing committee / Arbiter's team he/she will be penalized from the tournament immediately and report will be given to AICF and legal action will be recommended.

- 📄 **Draw Claim:** As per "The laws of chess" it's mandatory to write a game, if there is threefold repetition then player can claim to the consent Arbiter with the help of written notation sheet.

- 📄 **Discussion / Analysis:** As long as the game is in progress, a player may talk only to an Arbiter or to the opponent as permitted by "The laws of chess" (FIDE Official language will be allowed). Analysis is not allowed in the playing hall / playing arena.

📖 **Spectators:** Players who have finished their game will be treated only as spectators, will not be allowed in the playing hall / playing arena.

📖 **Protest:** Protest if any against the decision of Chief Arbiter or his assistants must be submitted within 15 minutes after completion of the game with a fee of INR 1,000. The protest fee will be refunded if the appeal is upheld. Player him/herself are only allowed to go for appeal.

📖 **Prizes:**

✍ One Player is eligible for one higher Cash Prize only.

✍ **For Women** - Player kindly check **W/F** mention or not in front of your name.

✍ **For Veteran** - Player kindly check **S60** mention or not in front of your name.

✍ For age category prize, player is eligible for his/her own age category prize only.

Example: U07 age category player is eligible for only U07 age category respectively.

✍ Name / FIDE_ID / Rating / DOB / Club / Category / Type / Gender

✍ Players are requested if any corrections inform to the Chief Arbiter / Pairing Arbiter.
